The undersigned further acknowledge that they will be liable for all damage to persons, livestock, or property that is caused by them or any persons (including, but not limited to, minors) under their care and control, and that arise out of, or are related to, the undersigned's entry into and participation in the Activities. UNDER CHAPTER 87, TEXAS CIVIL PRACTICE AND REMEDIES CODE, A FARM ANIMAL PROFESSIONAL IS NOT LIABLE FOR AN INJURY TO OR THE DEATH OF A PARTICIPANT IN FARM ANIMAL ACTIVITIES RESULTING FROM THE INHERENT RISKS OF FARM ANIMAL ACTIVITIES. A LIVESTOCK SHOW SPONSOR IS NOT LIABLE FOR AN INJURY TO OR THE DEATH OF A PARTICIPANT IN A LIVESTOCK SHOW RESULTING FROM THE INHERENT RISKS OF LIVESTOCK SHOW ACTIVITIES.

RELEASE FROM LIABILITY: The undersigned hereby RELEASE, ACQUIT AND FOREVER DISCHARGE AND AGREE TO DEFEND, INDEMNIFY AND HOLD HARMLESS Texas Junior Red Angus Association, and Texas Red Angus Association, their present and former directors, officers, employees, agents, and representatives and the respective heirs, administrators, executors, successors and assigns and any other person, firm or corporation from any and all claims, causes of action, suits and/or demands for personal injury, death or property damage, accrued or to accrue in the future, known or unknown, (collectively, "Claims") relating to or arising out of any negligent, grossly negligent and/or intentional or unintentional acts on the part of the undersigned in connection with entry into and participation in the Activities. Without limiting the foregoing, the undersigned agree that the TJRAA Parties shall not be liable to them, their family, heirs, administrators, executors or assigns for Claims arising from or related to the undersigned Contestant's entry into and participation in the Activities.

TJRAA parties, or any agent, attorney, or other representative of a TJRAA party as influenced the undersigned in causing him/her to sign this agreement. The undersigned understands that this agreement shall be binding on his/her heirs, executors, successors and assigns, that the agreement will be governed by the laws of Texas, If any part of this agreement is determined to be invalid or unenforceable, it does not the affect the validity of the remainder of this agreement. The undersigned agrees to the terms and conditions above, and acknowledges receipt of this agreement.
